ASSISTANCE PLUS ~~6~~ MONTHS / ~~10,000~~ KM WARRANTY PROGRAM

WHO MAKES THIS LIMITED WARRANTY (“WARRANTY”): This limited warranty is extended only to you, the original purchaser, and not to anyone who may purchase your vehicle from you during the term of the warranty. This limited warranty is made by the Independent Service Facility (“Facility”) who is so named on the original repair invoice and performed the service/repairs on your vehicle. This Warranty may be honored by any Facility participating in this program, or other authorized facility anywhere in the United States and Canada. This Warranty is not a warranty of CCI Inc., UNI-SELECT® Inc., either company’s affiliates, subsidiaries or any of their employees, or member companies. In addition CCI serves as the administrator only.

WHAT IS COVERED BY THE WARRANTY: This Warranty covers the following types of repairs and services:

- A. Braking parts: Pads, Shoes, Rotors, Drums, Calipers, Brake Cables – Master and Wheel Cylinders
- B. Steering parts: Tie Rod-In, Tie Rod-out, Pitman Arm, Idler arm, Ball joint, Control arms, Sway Bar, Centre link, Stabilizer
- C. Shocks: Struts, Cartridges, Front and rear shocks, bearing plates, brake pads
- D. Radiator, Fuel tank
- E. Exhausts parts: Mufflers, Exhaust pipes, Catalytic Converter
- F. Alternators, Starters
- G. Engine parts: Distributor caps&rotors, relays, Blower Motor, Compressor, Evaporator, Radiator hoses, V Belt, Serpentine, Tensioner, Oxygen Sensors, Mass Air Flow sensors

The Independent Repair Facility warrants that the above repairs and services performed at their location will be free from defects in materials and workmanship for ^{6 Month}~~6~~ months or ^{20,000}~~10,000~~ km, whichever comes first, measured from the date of the first repair and the odometer reading shown on the original repair order (“Warranty Period”). This Warranty is conditioned on the vehicle being subjected only to normal, non-commercial use, and receiving reasonable and necessary maintenance during the Warranty Period. **Warranty repair costs shall in no case exceed the costs of the original repair or service.** If there is a defect in either materials or workmanship within the Warranty Period, the Facility shall have the option to either perform remedial service work at no charge to you, replace the defective warranted part(s) without charge to you, or refund to you the entire charge for the warranted repairs, minus any previous refunds or credits.

WHAT YOU MUST DO TO OBTAIN WARRANTY SERVICE: You must keep a copy of the original repair invoice and present it when seeking service under this Warranty. If Warranty work is performed, you must temporarily surrender possession of the original repair invoice, or a legible copy of the same.

If you are unable to reasonably return your vehicle to the original service Facility and, then prior to any Warranty repair work being performed you must call the Warranty Administrator, at 1-855-276-9307 (toll free number, 24/7). The Warranty Administrator will direct you to the nearest participating Facility location. If there are no participating Facility locations in your area, you may take your vehicle to a non-participating service facility in your area. You must pay for the repairs and return to the original service Facility with a copy the repair invoice along with the defective part and the original repair invoice to obtain your refund.

WHAT IS NOT COVERED BY THIS WARRANTY: You must pay for any non-warranty service you order to be performed at the same time as the Warranty service. This Warranty will not apply to your repaired vehicle if it has been damaged by abnormal use, misuse, neglect, accident, alteration or “tampering with” (by other than the Facility or Facility employees). This Warranty does not cover replacement or repairs due to normal wear and tear. The Facility’s employees and/or agents do not have authority to modify the terms of this Warranty nor to make any promises in addition to those contained in this Warranty. This Warranty does not in any way include INCIDENTAL OR CONSEQUENTIAL DAMAGES (additional expenses which you may incur as the result of faulty repair or service). Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This Warranty gives you specific rights, and you may also have other rights, which vary from state to state.

AUTOMOTIVE REPAIRS EXCLUDED FROM WARRANTY: This Warranty does not cover repair(s) or replacement(s) except as listed in the section, “What is Covered by this Warranty,” even though the Facility may offer other services. Specifically excluded are any repairs involving replacement or removal of internally lubricated parts and other such repairs as listed below. Automotive repairs excluded from the Nationwide Limited Warranty include:

- I. ENGINE
 - a. Any internal repairs or replacement of internal components, or replacement of engine assembly.
- II. TRANSMISSION, TRANSAXLES
 - a. Automatic – any internal repair or component replacement.
 - b. Manual – any internal repair or component replacement.
 - b. Clutches – clutch component or assembly repair and replacement.
- III. DRIVE AXLE/DIFFERENTIALASSEMBLY
 - a. Any repair or component replacement requiring the removal of internally lubricated components or replacement of the drive axle/differential assembly.
 - b. Ring gear, pinion shaft and related gears
 - c. Associated bearing with above
 - c. Pinion seal
- IV. AUTO BODY, PAINT, MOLDING REPAIR
 - a. Any repair or materials related to auto body repair work.
 - d. Glass related repairs.
- V. TIRES
- VI. BATTERIES
- VII. USED OR SALVAGED PARTS
- VIII. PREVENTIVE MAINTENANCE SERVICES (excluding belt and hose replacement)
- IX. OIL CHANGES, FLUID CHANGES AND FLUSHES, WIPER BLADES, FILERS.
